

# CRUISE LINE ALCOHOL POLICY

## What can be taken on board?

CELEBRITY EDGE, OUTER HARBOR

EDGE

Many passengers are unsure about what can be taken on board and each cruise line's alcohol policy (i.e. whether bottles of alcohol are permitted, or if a corkage fee applies). To clarify what can and cannot be taken on board, see below for the alcohol policies of cruise lines that call into South Australia.

## SEABOURN

ADELAIDE

Seabourn has a significant amount of Epicurean Collection tours that may take you to a winery, distillery or other venue where you can purchase alcoholic beverages. Guests are free to bring those back to the ship and no corkage fees apply.

## PRINCESS CRUISES

Guests are permitted to bring one (1) 750ml bottle of wine or champagne on board per voyage, which can be consumed in their stateroom without a corkage fee. Additional bottles will incur a corkage fee. Duty-free purchases will be collected, stored and delivered to the stateroom on the last day of the cruise.

## CELEBRITY CRUISES

When embarking, guests may bring up to two (2) 750ml each bottles of wine on board per stateroom, subject to a corkage fee. Alcohol bought on board or while ashore will be stored and returned on the last day of the cruise.

#### CUNARD

Duty-free alcohol is available for purchase and will be delivered to the passenger's stateroom on the last day of the voyage. Passengers may bring one (1) bottle of wine or champagne per person on board (no larger than 750ml). If consumed in restaurants or bars, each bottle will be subjected to a corkage fee.

## HOLLAND AMERICA LINE

Guests can bring wine and champagne on board, but there is a corkage fee of USD \$20 per bottle (max 750ml in volume). Wine purchased during company-sponsored shore excursions at local wineries is exempt from the corkage fee, limited to one bottle per person.

#### ROYAL CARIBBEAN INTERNATIONAL

Guests can bring one (1) sealed 750ml bottle of wine or champagne on arrival of the tour. Bottles purchased during the voyage will be stored by the ship and returned on the last day of the cruise.

#### Perishable items

Please note that perishable items, such as fresh local produce, are not permitted to be brought on board any cruise ship, and will be disposed of at the gangway. Sealed, non-perishable food items may be permitted. Please check the ship's policy to determine whether it is allowed on board.

#### MSC CRUISES

All alcohol purchases brought in from port will be held for safekeeping and delivered to passengers' cabins on the cruise's last evening.

## VIKING CRUISES

Guests may bring alcohol and beverages with them, purchase alcohol ashore at destinations that sell alcohol, or purchase them from the onboard shop. Alcohol can be consumed in staterooms or in public spaces, including the restaurants. There is no corkage fee.

#### PONANT

Guests can bring alcohol on board at the start of the voyage or from a shore experience and consume on board without charge.

#### AZAMARA

Wine, beer or other liquor may be brought on board to be consumed in guest staterooms; if consumed in a public area on the ship, each bottle will be subject to a USD \$10 corkage fee. No corkage fee applies to alcohol purchased through Azamara's Bon Voyage Gift selection. All other alcohol purchased on board or while ashore will be stored and returned on the last day of sailing.

## NORWEGIAN CRUISE LINE

Guests are allowed to bring wine and champagne on board. If passengers purchase alcohol at a port or on board shops, it will be stored and available for pick up on the final night or morning of departure. Wine and champagne can be brought on board, but there is a corkage fee starting from USD \$15 based on bottle size. This fee also applies to alcohol sent to the ship or purchased from other sources. Beverage package holders are exempt from the corkage fee.

#### SILVERSEA

Guests are permitted to bring alcohol onboard on embarkation and at ports of call, although it must be included in their luggage. Guests should ensure they carry a receipt showing taxes and duties paid. There is no corkage fee.
