ABOUT ACCOMMODATION LISTINGS

ACCOMMODATION TYPES

Accommodation providers must offer an accommodation establishment bookable on a short-term basis. Only one accommodation listing can be created per physical property. There are 11 property styles available in the ATDW for accommodation providers to select from.

- ▶ **Apartments** – This property style is required to have self-catering facilities (sink, refrigerator, microwave) and have bedrooms, bathrooms and linen provided.
- ▶ **Backpackers and Hostels** – Typically dormitory style short-term accommodation for guests and communal facilities available (shared bathroom, social areas, self-catering shared kitchen).
- ▶ **Bed and Breakfast** – Guests will have private bedrooms, with or without private bathroom facilities. Rooms can be in either the main house or a separate building.
- ▶ **Caravan, Camping and Holiday Parks** – Defined areas with shared amenities providing any of the following forms of accommodation or the space for: cabins, tents, touring caravans, motor homes, caravans, holiday homes, glamping, chalets and bungalows.
- ▶ **Cottages** – Stand-alone dwellings which includes private bathroom facilities and kitchen with cooking facilities.
- ▶ **Farm Stays** – Must offer guests the opportunity to observe or become involved in farm life on a rural property. Accommodation ranges from self-contained or dormitory style to staying in the homestead with the family.
- ▶ **Holiday Houses** – Stand-alone residences for holiday letting which may have several bedrooms allowing a group of guests to stay there together. Typically the house will include full facilities.
- ▶ **Hotels** – Short-term accommodation to guests and will have a licensed bar onsite. Rooms can include private bathroom facilities and full or limited cooking facilities. Meals can be available onsite and additional guest services available.
- ▶ **Motels** – Typically designed to attract motorist and usually offer units or suites for guests. Individual bathrooms and on-site parking are available.
- ▶ **Resorts** – This property style is often in a location or has facilities available that encourages guest to have an extended onsite holiday. Offerings may include swimming pools, day spa, daytime activities, night life or childcare. Rooms include private bathroom facilities and meals are available onsite.
- ▶ **Retreat and Lodges** – Situated in secluded areas and ideal for quiet relaxation and immersion into a unique environment setting. Style of accommodation can range from basic to luxury and offer a specific or niche experience.

ACCOMMODATION ON SOUTH AUSTRALIA.COM

All South Australian accommodation listings and room/service type listings will be published on southaustralia.com.

There is an automatic pre-determined format which all accommodation listings will display in when published. It is recommended for businesses to familiarise themselves with the layout of distributor websites including southaustralia.com.

- ▶ Don't enter HTML, email addresses, pricing information and contact details as these will go in another section.

ACCOMMODATION TYPE

It is recommend to select the accommodation type that represents your business best. Should there be multiple you believe the business aligns with best, then they may also be selected.

- ▶ Read the description in the box to check if the accommodation type is relevant to you.
- ▶ Click the box to select the accommodation type relevant to you.
- ▶ It is recommended to select no more than three accommodation types.

Optimisation Tip: *These will influence how your business is filtered on websites, so it's important to only select the most relevant options for your business.*

Apartments

Apartments have self-catering facilities (sink, refrigerator, microwave etc.). Must have separate bedrooms fully equipped kitchens, one or more bathrooms, usually a washer and dryer, and sometimes a balcony or patio. Towels and linens are provided. Daily or weekly service and other hotel conveniences are usually available.

Backpackers and Hostels

Backpackers and Hostels provide short-term accommodation to guests, usually dormitory style. These are typically larger communal buildings offering room types ranging from individual rooms to dormitory style. They typically have a shared bathroom, social areas and self-catering facilities. Residential Colleges and University Halls of Residence can be included here.

Bed and Breakfast

Bed and Breakfasts range from a family residence to a guesthouse, homestead or inn. Guests will have private bedrooms, with or without private bathroom facilities. Rooms may be either in the main house or in a separate building. Breakfast is a component of the tariff and is provided either in the form of daily provisions or is prepared by a host.

Caravan, Camping and Holiday Parks

Caravan, Camping and Holiday Parks are defined areas with shared amenities providing any of the following forms of accommodation or the space for: cabins, tents, touring caravans, motor homes, caravans, holiday homes, chalets and bungalows. They may be with or without central entertainment and sports facilities, shops and restaurants.

Cottages

Cottages are stand-alone dwellings which includes private bathroom facilities and kitchen with cooking facilities. The dwelling may be located within the boundary of an accommodation complex.

Farmstays

Farm Stays offer guests the opportunity to observe or become involved in farm life on a rural property. The accommodation ranges from self contained or dormitory style to staying in the homestead with the family.

Holiday Houses

Holiday Houses are stand-alone residences for holiday letting which may have several bedrooms allowing a group of guests to stay there together. Typically the house will include full kitchen facilities, private bathroom facilities and laundry facilities.

Hotels

Hotels provide short-term accommodation to guests and will have a licensed bar on-site. Rooms may include private bathroom facilities and full or limited cooking facilities. All or some meals will be available either in a restaurant located on-site, or through room service. A number of additional guest services may be available, including a swimming pool, games room and/or child care.

Motels

Motels are typically designed to attract motorists and usually offer motel units or suites for guests and on-site parking. Individual bathroom facilities are available. Breakfast is usually available and units are serviced daily. These rooms may contain limited cooking facilities.

Resorts

Resorts provide short-term accommodation to guests in a location that encourages an extended on-site holiday. Offerings may include swimming pools, day spa, child care, restaurants, licensed bars, tour desk, night life and day time activities. Rooms include private bathroom facilities and may offer some cooking facilities. Meals are available in an on-site restaurant or through room service.

Retreat and Lodges

Lodges are situated in secluded areas ideal for quiet relaxation and immersion into a unique environment setting. Style of accommodation can be from basic to luxury and offer a specific or niche range of activities such as skiing, diving or uniquely Australian nature experiences.

LOCATION

The owning organisation's address for the ATDW account will appear in the 'Organisation address' selection. If this is different to the main address of your tour operations, click 'Define another address' and enter the location information.

A Google Map drop down box will appear to assist in finding the location. If the location doesn't look accurate on the map, you can click on the pin and move it to the correct location.

If your business has multiple locations for the different accommodation properties, it is advised to create a new listing. An ATDW listing in the accommodation category is to be used for a single property address and have all bookable sites under the single address listed as an accommodation type in the listing.

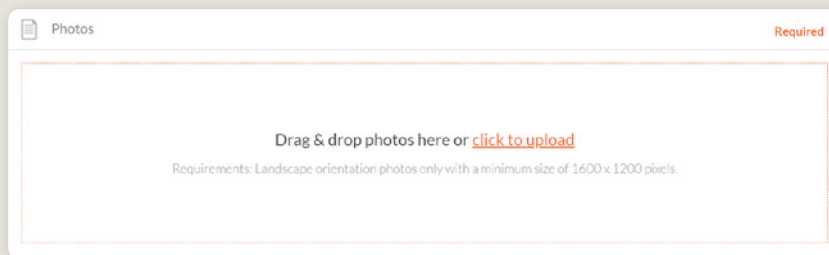

PHOTOS

1. To upload, either drag the image from your device and drop into indicated field or click the 'click to upload' hyperlink and select the desired file.
2. Photos are subject to specific requirements because the images are promoted on different websites with different image specs. To avoid the image becoming distorted or illegible, the ATDW photo requirements must be adhered to so those that are marketing the product on your behalf, are doing so with clear and quality imagery. If your image doesn't meet these requirements, an error box can appear. If it does, please review image details and try again.
3. Once the photo is uploaded, enter alternative text and further caption details.
4. Click 'Save Photo'.



Specific requirements for photos in ATDW can be found in the guidance box on the right of the screen. This includes:

- ▶ Minimum photo size is 1600 x 1200 pixels.
- ▶ Maximum photo size is 10mb.
- ▶ Minimum 1 photo, maximum 10 photos.
- ▶ Portrait sized photos, posters, brochures, logos or photos with written text are not accepted.
- ▶ Alternative Text (Alt text) is mandatory. Write a brief description of what's in the photo. This benefits the visually impaired and your SEO (Search Engine Optimisation). Captions can add more detail to your photo.




Specific requirements for videos in ATDW can be found in the guidance box on the left of the screen. This includes:

- ▶ Do not upload videos containing advertisements.
- ▶ Keep your videos 30-90 seconds in length.
- ▶ All videos must be publicly available on YouTube or Vimeo.
- ▶ A maximum of 10 different good quality videos are accepted.

Optimisation tip: Drag and drop your videos to order them. The video with the star will be your primary video.

- ▶ **Sleeping Capacity:** this is the total number of guests which are able to stay at your property, not per room/site. For example, a hotel can sleep up to 300 guests or a retreat with 10 bookable villas (up to 6 guests per villa) can sleep 60.

The Deal/Offer functionality in ATDW allows you to further promote your accommodation through advertising any special rate, discount, bonus offer or packages for a set period.

A Deal/Offer will appear on southaustralia.com directly under the product description on the accommodation or site/room type product page. There are two ways to create a deal/offer depending on where you want to deal/offer associated.

GENERAL OPTIMISATION TIPS

OUR TOP TIPS

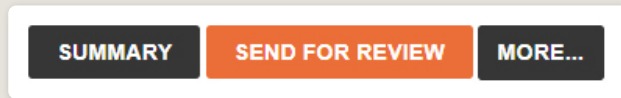
- ▶ **We always recommend adding in as many details as you can.**
The more information included within your listing will increase the compatibility of your information on other distributor websites and optimise the visitor experience.
- ▶ **Update your listing regularly.**
Listings are required to be updated at minimum every 12 months. It's best practice to set a time aside every six months to review your listing and update any information that has recently changed.
- ▶ **Use the 'Guidance' section.**
The ATDW provides a guidance section to assist with the optimisation and compliance of the information in the respective fields. This guidance section can be found on the right of your screen and provides examples of good practice listings.

LISTING APPROVAL PROCESS

SUBMITTING A LISTING

Once all information has been uploaded/updated, click the 'SEND FOR REVIEW' button in the top right corner of the web page.



REVIEWAL PROCESS

All South Australian listings are sent to the South Australian Tourism Commission (SATC) for review. The SATC will quality assure the ATDW listing. This means SATC will check over all information to ensure it is compliant with ATDW guidelines and is optimised for distribution.

The review process can take up to 5 business days to complete. Once reviewed, SATC will process either an approval or rejection. You will be notified of the outcome via email. The email will be an automated template with optional additional comments in bold text.

Please review any emails issued from the ATDW as these are important to notify you of any necessary amendments, recommendations or actions you may need to take.
